



## **RELEASE FORM**

The undersigned (whether one or more the "Participant") in consideration of his acceptance on the Lanier Striper Club Fun Fest as applied for by the undersigned (the "Fun Fest"), on behalf of himself and his heirs, legal representatives and assigns agrees to and hereby does release Lanier Striper Club, LLC, its officers, employees, agents, directors, and all those acting for or in concert with any of the foregoing and respectively their heirs, successors, administrators, executors and assigns (hereinafter respectively and collectively referred to as "Lanier Striper Club, LLC") from and jointly and severally agrees to indemnify and hold each of Lanier Striper Club, LLC harmless from and against any and all liabilities, costs and expenses (including attorney's fees and expenses of litigation) which they may jointly or severally incur to the Participant, his heirs, legal representatives or assigns, in respect of any claim, suit or cause of action on account of any personal injury, loss of health, financial loss, or damage to property directly or indirectly sustained by him as a result of his participation in the Fun Fest, including without limitation any such injury, loss or damage resulting from and failure to perform on the part of any person with whom Lanier Striper Club, LLC has contracted for goods or services in connection with the Fun Fest, and civil commotion force majeure, acts of God or government, or other wise of any negligence on the part of Lanier Striper Club, LLC and the Participant further agrees to and hereby does release Lanier Striper Club, LLC from and jointly and severally agrees to indemnify and hold each of Lanier Striper Club, LLC harmless from and against, any and all liabilities, costs, and expenses (including attorney's fees and expenses of litigation) which they may jointly or severally incur to any person, his heirs, legal representatives or assigns, in respect of any claim, suit, or cause of action on account of any personal injury, loss of health, financial loss, or damage to property directly or indirectly sustained by such person, his heirs, legal representatives or assigns, as a result of the Participant's action, series of actions, or failure to act in or in connection with the Fun Fest or otherwise. The undersigned declares that he is 21 or over and in good health and agrees that as a condition to participating in the Fun Fest he will have obtained in advance and at all times will have with him all required licenses and suitable equipment and will obey all applicable laws, written or oral rules, direction, practices and procedures of Lanier Striper Club, LLC whether with respect to safety conduct or otherwise; and in recognition of the danger in which the undersigned voluntarily subjects himself in connection with the Fun Fest, hereby knowingly, freely and voluntarily assumes the risks and waives any right or cause of action, of any kind whatsoever arising out of or as a result of such Fun Fest activity and participation from which any liability may or could accrue to Lanier Striper Club, LLC and covenants never to sue Lanier Striper Club, LLC on the account thereof.
